THE MOROCCAN EDUCATION FOR EMPLOYMENT FOUNDATION (EFE-MAROC) WAS ESTABLISHED IN 2007 AND HAS TRAINED NEARLY 3,200 YOUTH IN ITS JOB PLACEMENT PROGRAMS, PLACING 73% IN JOBS WITHIN SIX MONTHS. ADDITIONALLY, EFE-MAROC HAS TRAINED 12,200 YOUTH AT YOUTH CENTERS AND PUBLIC UNIVERSITIES THROUGHOUT MOROCCO IN ITS PATHWAYS TO A JOB TRAINING PROGRAM. THIS YEAR, EFE-MAROC WILL CLOSE OUT ITS 5-YEAR PARTNERSHIP WITH THE MASTERCARD FOUNDATION WHICH IMPROVED THE JOB SEARCH AND WORKPLACE SKILLS OF OVER 13,800 MOROCCAN YOUTH AND BUILT THE CAPACITY OF PUBLIC UNIVERSITIES AND YOUTH CENTERS THROUGHOUT MOROCCO.
