THE MOROCCAN EDUCATION FOR EMPLOYMENT FOUNDATION ("EFE-MAROC") WAS ESTABLISHED IN 2007 AND TO DATE HAS TRAINED MANY YOUTH ON EMPLOYABILITY AND JOB TRAINING AND PLACEMENT PROGRAMS. IN OCTOBER 2019, EFE COMPLETED ITS FIFTH AND FINAL YEAR AS A MAJOR IMPLEMENTING PARTNER IN USAID'S CAREER CENTER PROJECT LED BY FHI360. AS THE PROJECT CONCLUDED, THE MOROCCAN MINISTER OF HIGHER EDUCATION ANNOUNCED THAT THE CAREER CENTER MODEL WILL BE EXPANDED TO ALL PUBLIC UNIVERSITIES AND OFPPT VOCATIONAL CENTERS, A GREAT ILLUSTRATION OF THE SYSTEMATIC IMPACT AND THE PROGRAM'S SUCCESS. . EFE-MAROC CONTINUED ITS WORK WITH STRATEGIC PARTNERS CITI FOUNDATION AND BOEING FOR THE SEVENTH AND THIRD CONSECUTIVE YEARS, RESPECTIVELY. BOTH PROGRAMS UTILIZE ACCENTURE'S EMPLEA+ PLATFORM TO IMPROVE GRADUATES' DIGITAL SKILLS AND COMPETENCIES.
